# 1. Minutes of the General Assembly held on Wednesday 16 June 2010

The Minutes of the General Assembly held on Wednesday 16 June 2010 had previously been circulated and were approved.

2. Election of ICA Board members - Announcement of candidates and voting

Paper 1 List of candidates

The following had been proposed and seconded, for the election of only two members to the ICA Board.

Philippe Choquet informed the ICA members he would step down from the ICA Presidency at this General Assembly, as he had been asked to take the lead in developing the Global Confederation of Higher Education Associations in Agricultural and Life Sciences (GCHERA). However he stated he was willing to be involved in the general running of ICA and submits his candidature to the vote, as his term of office was expiring.

Voting then took place by attendees who were representing their institutions which had paid their 2010 membership subscriptions. The result of the vote is recorded under minute 6.

## 3. Report of the President on behalf of the ICA Board -

Paper 2 President's Report was tabled as a powerpoint presentation.

Philippe Choquet presented his report outlining what had been achieved by ICA since the last General Assembly and the ICA Board's vision for the future to:

# 1. Facilitate networking:

- between ICA's members through the development of an effective website, and conferences like GCHERA, and those between ICA and APLU which will now be extended to include the Canadian Faculties of Agriculture and Veterinary Medicine (CFAVM)
- towards and within the Standing Committees to achieve a greater strategic density through the convergence of ICA's constituencies under what is referred to as the ICA umbrella
- towards international organisations, and especially through ICA's presence at the GCHERA level.
- 2. Develop visibility/lobbying at the European and global level
- at the EU level in order to get political recognition (due to the core societal issues addressed by
  the life science universities). He had the opportunity to meet with a member of Commissioner
  Dacian Ciolos's cabinet and with European MPs during the past year in order to promote ICA as
  a European organisation representing the interests of Life Science universities.
- at the international level, through GCHERA. The development of GCHERA as a Confederation of higher education associations will be a significant tool to communicate globally about ICA and its member institutions in the life sciences. In doing so it should open up new opportunities for cooperation and services to ICA's members.
- 3. Structure the association to ensure its sustainability
- the ICA Board is working to develop a balanced budget and to increase its income. The lack of finances is a key factor holding back the development of ICA's services for its members
- The ICA Secretary General has been working very closely with the President and the ICA
  Secretary in a largely virtual environment. Although this works effectively, ICA's representation
  at the European level would be considerably enhanced with a permanent secretariat based in
  Brussels. The establishment of a permanent secretariat is the long term ambition of the ICA
  Board.
- Through Information Technology: the ICA website has significantly been improved thanks to the
  efforts of Simon Heath. The Website and the Newsletter is a key success factor to implement
  ICA's communication strategy with our members.

For the forthcoming year ICA should focus on enlarging its strategic density to enable the ICA Board to speak with a European voice in representing the Life Science universities at the European level. The political commitments of the universities should reinforce the "afectio societatis" with ICA. The development of inter institutional communication is a prerequisite to reinforce ICA's lobbying activities in the European arena. ICA's global networking activities through GCHERA will open up new horizons for the association.

In order to meet the expectations of its members, the association relies before all on personal commitments o fits members. Philippe Choquet particularly thanked the members of the Board for their commitment to developing ICA for the benefit of members, and also thanked Simon Heath and Marie Dubruque for their support.

Philippe Choquet announced to the General Assembly that the ICA Board, in accordance with the Statutes, had voted for Guido Van Huylenbroeck to be the next President of ICA. Guido Van Huylenbroeck is Dean of the Faculty of Bioscience Engineering at Ghent University. Guido Van Huylenbroeck had accepted the nomination by the Board.

Note<sup>1</sup>: "afectio societatis" is the French legal concept that means that two people or more share the same idea, and personally commit themselves to achieving the purpose of the association.

Mika Rekola, ICA Treasurer, briefly presented the Income and Expenditure Account 2010. For the year 2010, there was a decrease of ICA's total income in comparison with 2009. This reduction in income was manly due to the lack of income from projects. In addition less than half of the budgeted 25.000 € income from sponsorship was achieved. This resulted in deficit of 25.150 €, instead of the budgeted deficit of 11.270 €. Mika Rekola stated that ICA has thus a structural problem related to its financing of its planned expenditure because the planned sponsorship had not yet been achieved.

Turning to Balance Sheet at 31 December 2010 Mika Rekola commented that the opening balance was reduced at the year end as a result of the deficit on the Income and Expenditure account. The 2009 Balance Sheet is restated here after the removal of the University of Eastern Finland Account on the advice of the 2009 account auditors. The assets at 31 December 2010 included the closing assets of 3.096 € held on behalf of the Standing Committee IROICA. The closing net capital of 82.487 € falls just below the target of 80.000 € for the ICA reserves if the closing assets of IROICA are deducted.

Finally, Mika Rekola reported that there had been a discussion by the Board regarding raising the annual income of ICA. ICA essentially relies on membership fees to finance the expenditure on activities in support of members and general overhead costs. Attempts had been made to raise income through sponsorship but this has been unsuccessful. Moreover, the membership subscription fees had been unchanged for nearly a decade, which represented a decrease in real value of between 20-30 per cent due to inflation. He made the recommendation to the General Assembly that the membership subscription system should be raised to redress this effect of inflation.

Finally, Mika Rekola thanked the Executive Secretaries Ida Krogager and Marie Dubruque, ICA Secretary General Simon heath and the auditors (Henrik Zobbe and Philippe Caron).of the 2010 accounts for their work

The accounts for 2010 were accepted as such by the General Assembly.

The Budget for 2011 was discussed. It showed a deficit of 2840 €. Jaume Lloveras asked what

would happen if ICA had to face a 3.000€ deficit. Philippe Choquet said that ICA would draw on the reserves.

Didier Pillot asked what the expectations were in terms of projects for the future. Simon Heath said that ICA was keen on developing projects but the problem is the lack of staff resources. However, members could play a leading role if they have an interest in some funded project and ICA would be most willing to support their applications. ICA can have a role to support in dissemination and valorisation.

Philippe Choquet asked the General Assembly to approve the Budget 2011. *The Budget was approved by almost the majority of the votes, there was one vote against.* 

## 5. Membership subscription rates 2012

Philippe Choquet proposed to raise the full membership subscription from 1000€ to 1200€ for 2012. The membership subscription had not been increased for almost 10 years and had become devalued through inflation as indicated by Mika Rekola in his report. His proposal was made to address this position. In future years the General Assembly would be requested to raise the membership subscription in line with inflation. Where there is an agreement with the AGRINATURA and CASEE for a joint membership subscription the ICA membership fee would be reduced to 1100€. Simon Heath will have discussions with AGRINATURA and CASEE with regard to whether the joint membership subscription for AGRINATURA and CASEE would also be changed. The proposal to raise the full membership subscription to 1200 € for 2012 was approved with the proposal to increase the membership subscription in line with inflation in future years.

## 6. Results of ICA Board Elections

Anne Dutriaux, International Relations Officer at LaSalle Beauvais, counted the votes with the help of two students from the hosting institution. Following the vote of the General Assembly, Philippe Choquet was reelected with 18 votes and Krystyna Gutkowska, with 11 votes.

Philippe Choquet thanked the General Assembly for its confidence and said that it was very positive to have 4 candidatures for the Board. He welcomed his re-election and that of Krystyna Gutowska to the Board for a send term of office. He also thanked the other candidates for putting their names forward for election and their obvious commitment to supporting the development of ICA for its members. He hoped that they would wish to be nominated again at a future election.

Philippe Choquet handed over the Chair of the General Assembly to Guido Van Huylenbroeck.

## 7. Report of the Secretary General

The President had asked Simon Heath gave an overview of the work of the Secretary General in the past year since the last ICA General Assembly in 2010. The Secretariat, comprising Simon Heath and Marie Dubruque, had been involved in supporting 3 Board meetings, 9 Secretariat meetings, an ICA Council Meeting and the current General Assembly. Simon Heath had presented ICA's activities at the Standing Committee Conferences of AGRIMBA, CASEE, ERABEE and IROICA. He had supported the transfer of the Secretariat from Copenhagen to Beauvais involving training of the new ICA Secretary in ICA procedures, particularly for managing the finances and the collection of membership subscriptions. Simon Heath had further developed the ICA website and the delivery of the new format Newsletter from the website software. He had attended ICA's associated networks annual meetings of CEDIA and APLU. He had also attended two meetings of the GCHERA Executive which had led to the proposal for the GCHERA to be reformed as a Confederation of higher education associations like ICA and APLU.

#### 9. Report of the Chair of the EAALS Board (European Accreditation Agency for the Life Sciences)

Paper 7 EAALS Report to be tabled as a powerpoint presentation

Simon Heath (EAALS Executive Secretary) made a report on behalf of Andrew Cobb the Chair of the EAALS Board who unfortunately could not be present. EAALS is in a start position and the biggest challenge is to fund the staff resources in order to establish EAALS as viable entity. Since 2008 EAALS has been as Associate member of ENQA one of the bodies currently in place to oversee the functioning of accreditation agencies. In 2011 EAALS is undertaking a review of International Master of Science in Forest Policy and Economics (FOPER) which is led by the Universities of Belgrade and Sarajevo in South Eastern Europe along with other universities in the region.

At the 31 December the EAALS Balance Sheet sowed a net capital deficit of 2250 € which was a loan from ICA in 2010, to cover the membership fee of ENQA in 2010. The loan should be repaid in 2013. In addition EAALS received a small grant in 2010 of 300€ to cover the printing of flyers and a banner stand in order to promote EAALS. There was no other income and expenditure in 2010.

### 13. Statement by incoming President

Guido Van Huylenbroeck said that he welcomed the opportunity of becoming President of ICA and steering ICA over the coming year. The main activity in which he was taking the lead was the ICA Rectors and Deans Forum to be held at Ghent University from 3 to 4 November 2011. The Forum would address *Life Science Universities and Faculties: Meeting Challenges and Expectations*. The objective was to discuss the future development of our universities and faculties in making a unique contribution to the development of the rural economy, and the food and non-food chains. Our stakeholders had been invited to make presentations in order to allow participants to place the contribution of universities in the wider context.

Guido Van Huylenbroeck concluded by thanking Philippe Choquet for his contribution to ICA during his Presidency. The GCHERA conference, led by ICA and APLU, would in the following days start the discussion on how can support ICA members reaching out globally. Philippe Choquet, through his initiative to reform GCHERA as a Confederation of Higher Educations Associations, has established a framework to allow such discussion to proceed in a meaningful way.
